First of all a/v content (Bronchoscopy) can be provided using DICOM files, so all the a/v data distributed on PSNC server will be uploaded using DICOM files and PACS servers.

The following data will be stored at PSNC facilities (these also indicate possible retrieval/analysis criteria):

- Disease type according to ICD10 supplemented with disease description and manual description added by the specialist
- Procedures according to the ICD9 (A international classification system for surgical, diagnostic and therapeutic procedures) supplemented with the description of the procedure
- Results of laboratory analysis, including date of the analysis. An example can be morphology, biochemistry, urinalysis or gasometry.
- Description of EKG and date of examination
- RTG examination results, including DICOM files, date of examination and description of results prepared by the specialist
- TK examination results, including DICOM files, date of examination and description of results prepared by the specialist
- Description of USG examination and date of examination
- Description of patients treatment
- Epicrisis
- Recommendations for further treatment
- Bronchoscopy examination results, including DICOM files, date and description
- Information about patient (pol. Wywiad), including complaints, allergies, addiction, blood type, contact with tuberculosis, etc.
- Medical observations
